- **If a participant does not start in a competition or in some of the disciplines, the participation fee will not be refunded.**
- **Late registrations on the day of the competition, are generally not allowed, but, if possible, costs additionally 10 Euros.**

7. EVENTS

100m, 400m, 800m, 3000m (W), 5000m (M), discus, triple jump, high jump, shot put, 5000m race walking, long jump, javelin.

8. CONDITIONS OF ATHLETICS EVENTS

- Participants of long jump, triple jump and throwing events have **4 (four) attempts** for each age group. **No final attempts.**
- In the running disciplines participants **only have final races** (no preliminaries).
- In high jump Women and Men **Starting Height - 0,80 m; Progression – 5 cm.**
- All non-defined problems will be solved by the organizer of the competition together with the chief judge and a representative of LVVA. Competitions are held according to World Athletics (WA) and WMA regulations.

- Participants may participate only in the form of athletics clothing and sports equipment should also comply with WA rules and regulations. Athletes are advised to wear a national team uniform approved by their national federation.
- The competition bib issued to the participant must be properly affixed (in four corners), the bib must not have inverted or folded edges. If these conditions are not met, the participant will not be admitted to the start.

10. DOPING CONTROLE

Competitors may be subject to doping control in accordance with WADA regulations.

11. PROTESTS

- Any protests will be considered in accordance with Article 146 of the World Athletics Competition Rules.
- In case of submission of a protest, the team representative must submit it in writing, together with a deposit of EUR 20.00 (twenty euros), to the Chief Judge of the competition within 30 minutes after the announcement of the results.
- Other unmentioned problems and situations will be solved together with the chief judge of the competition and representatives of LVVA.

12. PRIZES

- Winners are determined according to the World Athletics competition rules.
- I, II, III place winners in the Latvian championships will be awarded with Latvian championships medals in each age category.

13. COMPETITION RESULTS

- All results are published in printed form on the information desk.
- The results of the competition will be available at: www.lvva.lv.

14. MEDICAL SERVICE

- Each competitor is responsible for their own state of health.
- In all competitions organized by LVVA, a nurse or doctor is provided, who, if necessary, helps the athlete in case of a minor injury.
- For more serious situations, there is an emergency service, requiring a telephone call to 112, the national emergency number.

15. MANAGEMENT

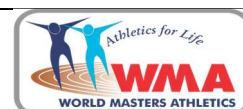
- Expenses of the competition organization are covered by LVVA.
